Board Trip to Albany and Denmark

In recent years the PathWest Board has began making annual trips to visit regional collection centres and laboratories. These trips provide Board members with an understanding of the procedures, practices, challenges and allows regional staff to interact with Board members, and give insight into a 'day in the life' of a PathWest regional staff member. This month, Board members and the Chief Executive, Dr Narelle Hadlow, travelled to Albany and Denmark to visit the collection centres and laboratory.

Board members and Dr Hadlow travelled to Denmark on Wednesday, 4 April 2024, and had the opporunity to meet two dedicated laboratory assistants at the Denmark collection centre, Ms. Helen Tasker and Ms. Lesley Hunter. This collection centre is located in the heart of the town and Ms. Tasker and Ms. Hunter gave some background around how the collection centre was set up, describing the benefits of the location not only for PathWest but it's patients and the community as a whole.

An overview of services offered at this location were discussed including some domicilary services and assistance to local General Practioners and other health services in the area. The staff at the Denmark collection centre demostrated great passion and commitment to PathWest and their community. The visit was a great opportunity for Board members and Dr. Hadlow to touch base with two talented, long serving staff members to hear about their experience within the organisation and get an idea of how PathWest functions and serves the town of Denmark.

The Board meeting was then held at Albany Health Campus on Thursday, 4 April 2024. Mr David Clark, Medical Scientist in Charge, Ms Catherine Till and Ms Monica Neil, Senior Medical Scientists, presented an overview of the Albany Laboratory, and provided a focuson one of PathWest's Strategic Pillars "Engage, develop and inspire our people". Topics that were discussed included:

- The planned move to a 24/7 model at the Albany Laboratory
- Services offered including outpatient collections, domicilary and prison services to Albany Health Campus, Denmark Health Service, Plantagenet Hospital, Walpole Nursing Post and Albany Regional Prison.
- Albany as the Regional Support Services (RSS) HRplus user acceptance testing site
- Training and development at the Albany site

Ms. Till and Ms. Neil expanded on the training and development offered at the laboratory advsing the Board that Albany is well known for its training and development, taking on a high number of students from most of the larger universities. They had reached out to previous students placed at Albany and presented their stories and experiences to the Board including information on where they are now. The Board was pleased to see the career pathways available to staff in this region and remarked that it's great to see staff coming back to the area after their placements.

Mr. David Clark took the Board on a tour of the laboratory allowing Board members and Dr Hadlow to see the space and meet some of the Medical Scientists, Phelbotomists, Laboratory Assistants and Technicians. Board members had the opporunity to hear about the work being done in the Laboratory and see some of it first hand. Mr. Clark explained that the collection centre has recently upgraded the collection chairs to enable staff to better handle emergency situtions in which a patient might become unwell or faint. The Board also spoke with some of the staff in the Laboratory who gave insight on some of the processes and testing that is undertaken including Bacteriology, Haematology, Transfusion Medicine, Biochemistry and Molecular Diagnostics.

The Board would like to thank Mr David Clark, Ms Catherine Till, Ms Monica Neil and all of the staff in both Albany and Denmark for taking the time to meet and speak with the Board.
