### **July 2020 Board Meeting**

The inaugural Board Meeting was held on Thursday, 2 July 2020 at Fiona Stanley Hospital. The Director General, WA Health and PathWest Executive were also in attendance to provide a formal induction for Board members to PathWest. This was a great opportunity for our new Board members to meet the Executive team and receive a brief presentation of the great work that PathWest does as well as discuss some the current issues and challenges.

The members also enjoyed a tour of the FSH laboratory, providing a brief snapshot of the key work we do across multiple disciplines. As a part of the induction the Board was provided with the following presentations / information:

- An overview of the WA Health governance arrangements and the priority and focus areas from a System Manager perspective.
- The three (3) main focus areas for Boards are:
  - Safety and Quality as a priority for patients;
  - Clinical performance; and
  - Financial performance.
- The three main ICT WA Health priorities are:
  - Laboratory Information System (LIS);
  - Health Next (new infrastructure for whole of health); and
  - New imaging system.
- The operational management of the PathWest directorate, which included an overview as well as key issues and priorities.
- Summary of the 'big ticket' focus areas for PathWest. These include (but are not limited to):
  - Laboratory Information System (LIS) Replacement Project
  - Organisational structure
  - Financial transparency
  - Stakeholder engagement
