November 2020 Board Meeting

The November Board meeting was held at Fiona Stanley Hospital on Thursday, 5 November 2020. At this meeting the Board were provided with a very informative presentation by Dr's David Speers and David Smith relating to PathWest's role in supporting the WA COVID-19 response. Mr Kevin Taylor, Board member provided the below synopsis:

At the meeting the Board were informed about the early response of PathWest in developing an in-house PCR test to detect the virus, along with the early adoption of commercially available tests. The protocols and regimen developed resulting in quick turn-around times for results, at a time when the community was anxious to receive the outcome of their tests, are clearly outstanding and a credit to all Staff involved.

The Board noted the commitment to rural and remote communities throughout Western Australia with the positioning of rapid PCR platform permitting testing for COVID-19 at our regional laboratories and more recently, the establishment of testing allowing PathWest to form part of the national collaboration of sewerage surveillance of SARS-CoV-2 (ColoSSoS).

PathWest's assistance to private laboratories to establish their COVID-19 testing, along with regular input to and close interactions with the State Health Incident Command Centre (SHICC), Public Health Emergency Operations Centre (PHEOC) and the Communicable Diseases Network of Australia (CDNA) clearly illustrate that PathWest is considered a high-quality laboratory service relating to testing and the provision of expert advice. PathWest's reputation as being a centre of excellence was further exemplified by the numerous grants that it has been awarded to undertake translational research activities and public health investigations related to COVID-19.

The Board extends its thanks and appreciation for a fantastic job to all PathWest staff; not only for facilitating an outstanding COVID-19 collection and testing response, but also in their commitment to implementing a new LIS across its laboratories at a time when community expectations for pathology testing have never been higher.

- An inaugural meeting to occur at the end of November / beginning of December 2020.


Forensic Biology Advisory Council
