November 2021 Board Meeting

The November Board meeting was held at Fiona Stanley Hospital in the Pathology Building on Thursday, 4 November 2021. This was my first Board meeting as the new Chair of the PathWest Board, and it was quite a full agenda to get through.

Key matters for decision:

Risk Appetite Statement

As highlighted in the October Board Communiqué, PathWest is required to comply with the Department of Health Mandatory Policy MP0006/16 Risk Management (the policy) which sets out requirements for Health Service Providers (HSPs) to establish and implement a Risk Appetite Statement (RAS).

The Board reviewed and discussed the updated RAS. The Board approved the RAS subject to a couple of minor amendments, with the final version to be uploaded to the December Board meeting papers for information.

- **2021-22 South Metropolitan Health Service (SMHS) Service Level Agreement** The Board reviewed and approved the 2021-22 SMHS Service Level Agreement.
- **2021-22 Child and Adolescent Health Service (CAHS) Service Level Agreement** The Board reviewed and approved the 2021-22 CAHS Service Level Agreement. The Board noted the SLAs are a work in progress, with the format to continue to develop and evolve.

Key matters for discussion:

Strategic Risk Workshop

Liam Murphy, Manager Audit and Risk facilitated a Strategic Risk workshop with the Board to review and refresh the strategic risks to link with PathWest's new strategic goals. The focus of the Strategic Risk workshop was the recently launched Strategic Plan 2021-25, with the aim of capturing the key events, activities or issues that might prevent PathWest from achieving or pursuing the goal and lead strategies set out in the Strategic Plan.

The Strategic Plan includes Strategic Pillars, Goals and Lead Strategies. To keep things simple, the session was focussed on the strategic pillars and goals.

The Board conducted a comprehensive analysis of the strategic risks, ensuring a systematic risk analysis and assessment against each of those pillars. This included considering whether there are any:

- External factors that might hinder PathWest from achieving its goals (for example, failure to understand changing customer needs).
- Internal factors that impact the whole of PathWest and are fundamental to the way we do business (for example, a project or system like LIS).

This was the initial Strategic Risk Workshop, with a draft Strategic Risk Register capturing risks, causes and consequences raised by the Board to be developed, with a further strategic risk session (to refine the data) to be scheduled for early 2022.

HSS Security Network update

Following the OAG audit qualification in relation to network security and access, the PathWest Board invited the HSS Board Chair, Mr Michael Walsh and HSS Chief Executive, Mr Rob Toms to attend our November Board meeting. Mr Walsh and Mr Toms provided the Board with a clarification of cyber security across the Health Network and provided an overview of existing security practices and strategies, as well as highlighting any known weaknesses and current or future plans to address these.

Mr Walsh and Mr Toms explained the landscape around digital security, highlighting that healthcare is one of the most targeted IT areas for hackers as medical records hold 10 to 20 times more value than other sources of personal information given the amount of data able to be retrieved. The interest in hacking into healthcare data has increased due to COVID-19 both domestic and internationally. This was an informative session, with several key initiatives in the Digital Transformation Strategy explained including how HSS plan to support the WA Health Network in managing Cyber Security.

On behalf of the Board, I would like to thank Mr Walsh and Mr Toms for making the time to personally attend our Board meeting and for providing valuable insight into the current security practices and the future plans to ensure the WA Health system has adequate cyber security controls in place to keep our data safe.
