# **Strategic Risk Workshop**

Mr. Liam Murphy, Manager Audit and Risk Management attended this meeting to lead a workshop with the Board to discuss strategic risks. KPMG had been engaged to assist in refreshing the strategic risks, working closely with senior management and Executives. The Board reviewed and discussed the proposed refreshed list of risks, with the Board seeking further information and review for more specific risks related to PathWest. The Board agreed that a subsequent Strategic Risk Workshop should be held during the November Board meeting to review the updated risks.

The Board commended Liam Murphy for all his work in relation to the development of the draft strategic risk profile.

# Cybersecurity update

Chief Technology Officer (CTO), Mr. Tim Evans updated the Board on the development of a PathWest Cybersecurity Strategy, with the plan currently being reviewed by the WA Health Cyber Executive Committee. Once it is approved it will be part of the PathWest Information Security Incident Response Plan which sets out incident response methodology and lays out the steps, roles and responsibilities of departments and staff in the event of an incident.

#### **Finance and Business Performance Report**

Mr. Sandy Kerr, Executive Director Finance Procurement and Commercial Services presented the Finance and Business Performance report to the Board. The inclusion of the recently developed Financial Health Framework was well received, and it was beneficial to see trends developing and to identify focus areas. The Board appreciated the work on the framework and looks forward to seeing how it will evolve with additional indicators over time.

# **Acting Chief Executive Report**

The Board noted the State Mortuary Refurbishment Project has been awarded Practical Completion by the Department of Finance. As Board Chair, I attended the formal reopening of the refurbished State Mortuary with the Minister for Health and Chief Executive on Wednesday, 23 August 2023.
